It's registered 25 January 2002 under Societies Registration Act 1860 as a non-political, non-profit making, secular, non-government organization. Being voluntary development organization, Srishti grew out of the vision and needs of the grass root level people has numerous programmes across the Himalayan region in Uttarakhand, realized the need for a local unit for monitoring and evaluation of its regional projects. It further had a future vision which included intensive local immersion of strategy, as well as increased networking amongst both, government as well as non-government organizations and departments in the region. Srishti's tasks include information gathering, networking, database development, strategy development, monitoring and evaluation, idea incubation through pilot projects, up-scaling of successful pilots and the coordination of works with the state government of Uttarakhand and with various partner organizations. The mandate of the organization is rural development, with a specific focus on natural resource management. The results of these activities are successful, community managed initiatives which contribute directly to rural income increase, resource management and conservation.

Spread of Activities Area of Operation

Srishti is currently working in 291 villages in 08 blocks of 04 districts in Uttarakhand. Projects are implemented through the intensive field support of partner organizations across the region. Srishti's partner organizations fall into three main categories, those which are geographically situated in the rural regions of the state and implement projects on the ground; those which may be based out of central locations and have the technical expertise to guide others and enhance performance over time and those which are brought in from the outside for specific tasks such as impact assessments and evaluation studies. We work with 16,104 households impacting over 85,880 people in different areas of our operation.

An Overview of Srishti's Program

In the year 2022-23, Srishti Jan Kalyan Samiti worked in various areas, the details of which are as follows:-

Livelihood and Income Generation

Srishti uplift Rural community livelihood income generation activity Through Uttarakhand forest resource management project,

(UFRMP) Srishti did it through 164 self-help groups and 3 self-reliant Cooperatives. The following activities were carried out in this sequence:-

1-Agro-produce Sale

Agricultural produce was collected through self-help groups and sold through autonomous cooperatives.

Which mainly includes bhang, bhang jeera, red rice, bhang fiber, buransh juice, leh bery juice, turmeric, zinger, rajama etc.

2- Dairy Activity

1-For income generation from animal husbandry, interest-free loans were made available to the farmers through Bag Nath Autonomous Cooperative.

2- collection of Milk

Bagnath SRC collects milk from the producers of rural areas and sells it in the market. SRC also provide fodder to the milk producer in low cost.

3- Dairy Establishment

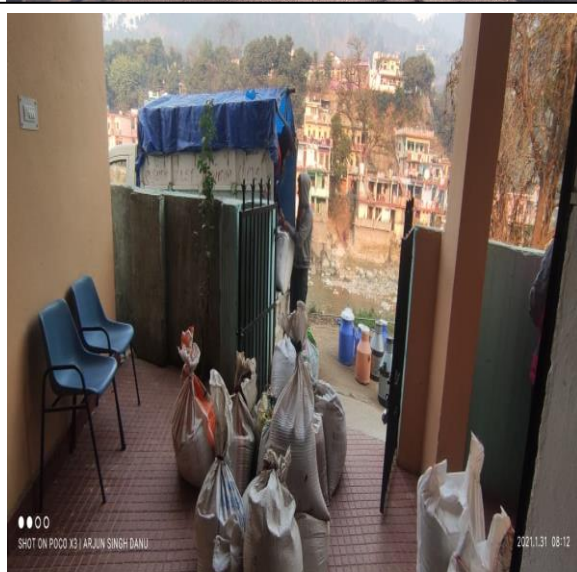
Through Bagnath self reliant cooperative we has been established a milk booth in the district head Quieter Bageshwar. A milk selling vehicle has also been kept at the centre, which starts selling 200 liters of milk in per day. Apart from milk, cheese; curd and whey are also sold at the centre. Milk producers are greatly benefited by this activity.

4-Value chain and grading

We train women in grading and packaging of their agricultural products so that they can get the right price for their produce.

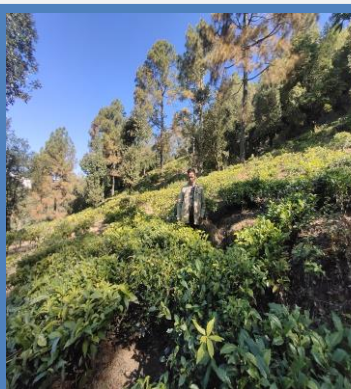
5-Marketing

For the marketing of agricultural and allied produce, a market network has been created by contacting buyers. For which the group of women's groups has been practiced. Now they themselves reach their produce to the buyers, do the accounting, due to which their economic condition has improved. Through this process, women have become self-sufficient in terms of livelihood and income generation. Certainly self-help groups and autonomous cooperatives have provide effective in making women self-reliant.

Eco restoration and horticulture promotion



HARIYALI

Along with eco-restoration, environmental protection and promotion, livelihood generation through horticultural activity was procured under **Hariyali program**. The program was conducted in 82 villages.

Along with this, plantation of trees, construction of Chal-khal and security works was done in the forests of Van Panchayat.

On the other hand, fruit and fodder leaf plants were planted in other villages.

PR TRAINING DETAIL

Srishti Jan Kalyan Samiti, as an associate organization with the Directorate of Panchayati Raj, trained the three-level panchayat representatives in Kotabagh development block of Nainital district on sustainable development goals and gram panchayat development plan. Under Rashtriya Gram Swaraj Abhiyan. Training was given to 5 Panchayats, 55 Gram Panchayats and Kshetra Panchayat members. Altogether 800 participants participated in the training.

Representatives were trained on Sustainable Development Goals, 9 Themes, Village Development Plan, apart from Solid Waste Management, Development Environment of Panchayati Raj, Right to Information, Procurement Manual, E-Governance etc.

Apart from this, information about health, cleanliness, agriculture was also given. Along with the information about all the government schemes, the participants were told how to take advantage of them.

Detail Project Report Work



Watershed Management, Almora, conducted a comprehensive survey in 92 revenue villages covered by the project for 2 micro watershed areas of the newly created Watershed Area, Development Block- Salt District- Almora.

After which a detailed project report was prepared, in which the details of natural resources, human resources, proposed works, arrangement of watershed management, cost and benefits, monitoring and evaluation of the project were given.

Source documents of information, basis of standard rates for work items, map, finance management and agreement letters were also included in the schedule of the detailed work plan.
